

**MINUTES OF THE REGULAR HARVEY CITY COUNCIL MEETING
MONDAY – JULY 13, 2020 - 7:00 P.M.**

Mayor Christopher J. Clark called to order the regular City Council Meeting Monday-July 13, 2020 held electronically at 7:05 p.m.

ROLL CALL:

Mayor Clark asked City Clerk Rosa Arambula to call the roll of Council Members. Present were Quinton Crudup, Tracy Key, Dominique Randle -El, Tyrone Rogers and Mayor Christopher J. Clark.

Absent at roll call were Alderwoman Shirley Drewenski and Alderman Marshun Tolbert.

Invocation was given by Alderman Rogers and Mayor Clark led the Pledge of Allegiance.

Alderman Key: "Point of order Mayor. I would like to add two discussion items to the agenda. 1st item: Termination of Deputy Chief Smith, 2nd item: Disciplinary action placed on Justin Winston."

Mayor Clark stated that those items are personnel items and not Council issues. He pointed out that this was controlled by the Mayor's office so he ruled it to be improper.

NEW BUSINESS:

APPROVAL OF MINUTES DATED: Monday - June 22, 2020.

City Clerk Arambula mentioned that Alderwoman Drewenski wanted to have it acknowledged in the minutes that there would be no additional dollars owed and they would not exceed the grant amount without Council approval referring to Resolution 2919.

Alderman Crudup made the motion to approve minutes dated June 22, 2020. The motion was seconded by Alderman Randle-El.

Alderman Tolbert arrived 7:10 p.m.

Voting Aye were Aldermen Crudup, Randle- El and Rogers.

Voting Nay was Alderman Tolbert

Alderman Key did not answer.

Absent at roll call was Alderwoman Drewenski.

ORDINANCES AND RESOLUTIONS FOR THE CITY OF HARVEY.

ORDINANCE # 3403 - An Ordinance amending Chapter 9-04 -420 of the Harvey Municipal Code - Loud or raucous Noise.
(Sponsored by Mayor Clark, and Alderman Randle-El)

Alderman Randle -El motioned to refer Ordinance to the Public Safety Committee. The motion was seconded by Alderman Tolbert.

Voting Aye were Aldermen Randle -El, Key, Crudup, Rogers and Alderman Tolbert.
Alderwoman Drewenski was absent at roll call.

Alderwoman Drewenski was absent at roll call.

ORDINANCE # - A Special Events Ordinance - An Ordinance ensuring adequate public safety and other City services. (Sponsored by Mayor Clark)

Alderman Randle -El motioned to refer Ordinance to the Public Safety Committee. The motion was seconded by Alderman Tolbert.

Voting Aye were Aldermen Tolbert, Key, Crudup, Rogers and Randle El,
Alderwoman Drewenski was absent.

RESOLUTION # 2920 - A Resolution repealing and replacing Resolution #2862A Class 8 request to correct scrivener error - Fuchs Lubricant - 17050 Lathrop
(Sponsored by Mayor Clark)

Mayor Clark stated that this request was to correct a scrivener error.
City Clerk Arambula pointed out that it should be Class 6B not a Class 8.

Alderman Tolbert asked Corporation Counsel if we were not in violations of the Open Meeting Act because it says on the agenda Class 8 and not Class 6B.

Corporation Counsel: "No because the Class 8 is the one you are repealing and replacing."

Alderman Randle El made the motion to adopt Resolution #2920. The motion was seconded by Alderman Rogers.

Voting Aye were Aldermen Tolbert, Key, Rogers, Alderwoman Drewenski, Aldermen Crudup, and Randle -El.

OLD BUSINESS:

ORDINANCE # _____ - An ordinance amending Chapter 5-04 of the Harvey Municipal Code-Vehicle Licenses. (Referred to Legislative committee June 22,2020.)

Mayor Clark: "Was there a Committee meeting held?"

Alderman Tolbert: "No Sir."

Alderman Randle El: "Point of Order Sir. I'd like to motion to have this removed from Legislative Committee and have a full Council vote with amendments." The motion was seconded by Alderman Rogers.

Voting Aye were Alderman Randle-El, Key, Crudup, Rogers, Alderwoman Drewenski and Alderman Tolbert.

**MOTION CARRIED
OUT OF COMMITTEE**

Mayor Clark mentioned that it was now removed from Committee and it now needed a motion to approve the Ordinance amending Chapter 5-04 of the Harvey Municipal Code Vehicle Licenses.

Alderman Randle – El made a motion to approve Ordinance amending Chapter 5-04 of the Harvey Municipal Code with one amendment being for the city stickers for motorcycles to be reduced to \$20 and \$5.00 for seniors over 65. The motion was seconded by Alderman Crudup.

Mayor Clark asked if there were any other points of order on this issue.

Mayor Clark stated that they would proceed with the motion of 5th Ward from 40 dollars to 20 dollars without the Ordinance in front of them.

Corporation Counsel: "The process is, if we have the Ordinance in front of us, we can state the changes and vote."

Alderman Randle – El: "I withdraw my motion. We will deal with this at the next meeting"

Mayor Clark asked for a motion to table.

Alderman Randle El made the motion to table. The motion was seconded by Alderman Rogers.

Voting Aye were Aldermen Randle-El, Crudup, Tolbert, Rogers, Alderwoman Drewenski and Alderman Key.

ORDINANCE # _____ – An Ordinance amending Chapter 5-112 providing for the regulation of Solicitors, Peddlers and Itinerant Merchants within the City of Harvey, Illinois. (Sponsored by Mayor Clark) referred to Legislative committee June 8,2020)

Mayor Clark "Has there been a Legislative Committee held?"

Alderman Tolbert: "No Sir".

Alderwoman Drewenski: "Point of Order. I do have question. I am getting these popup tents and people selling from their cars. They are selling masks, snow cones, hand sanitizer, etc. I want to make sure the City is aware they are doing this. The City is not getting any benefits from them. My concern is what if someone gets sick?"

Mayor Clark: "The City is very aware of this and that is why this piece of legislation was proposed to try to help with these particular issues. I need a motion to leave this in Committee."

Alderman Rogers motioned to leave this Ordinance in committee. The motion was seconded by Alderman Key.

Voting Aye were Aldermen Tolbert, Rogers, and Key
Voting Nay was Alderwoman Drewenski and Alderman Crudup .

City Clerk Rosa Arambula announced that there were no Public Comments received.

Alderman Tolbert asked the Mayor when the grass was going to be cut in the 2nd Ward because it was a concern of his residents.

Mayor Clark mentioned that Public Works would be out in the 2nd Ward and to have his residents call City Hall and make reports to the staff.

Alderman Key asked how many more meetings were going to be done electronic and what the procedure was for residents to have public comments.

Mayor Clark pointed out that the procedure was posted at the top of the agenda in red and he mentioned that it was also posted on the website and at City Hall.

City Treasurer Picket asked what the resolution number for the repealing and replacing Resolution for the class 6B.

City Clerk Arambula answered that the Resolution number was #2920.


Alderman Tolbert asked if they could send out a text message for public comment or put it on Facebook because he thought was hidden to the public.
