# MINUTES OF THE REGULAR HARVEY CITY COUNCIL MEETING MONDAY – FEBRUARY 11, 2019 – 7:00 P.M.

Mayor Eric Kellogg called the regular City Council meeting to order at 7:10 p.m.

Mayor Kellogg asked Clerk Nancy Clark to call the roll of Council members. Present were: Alderwoman Shirley Drewenski, Aldermen Joseph Whittington, Tracy Key, Donald Nesbit, Keith Price and Mayor Kellogg.

Absent was Alderman Christopher Clark.

The Invocation was given by City Clerk Nancy Clark and Mayor Eric Kellogg led the pledge of Allegiance.

### PRESENTATIONS:

Ms. Ridgeway (Dixie Oasis Project) gave an oral presentation and brought vision boards of her proposal and plans for the former Dixie Square Mall entitled Live, Work and Play.

Mayor Kellogg thanked Ms. Ridgeway for her professional presentation and thanked her for coming tonight.

Alderman Whittington "Asked Ms. Ridgway if she had a packet for the Aldermen."

City Clerk Nancy Clark "It was in your packets Alderman."

Alderwoman Drewenski "Are you proposing to purchase the land? What type of funding do you have allocated to this?

Ms. Ridgeway we are seeking a land grant and that the city give us time and if we don't complete the project in that time you can take it back. We have a network of investors behind us. This is more of a partnership if the City. And if the City is interested we will be willing to invest dollars. The City asked for the drawings and we invested and brought them tonight. We are looking for an inter-government agreement."

Alderman Key "I would like to make a motion to table and that they go back to the EDC The motion was second by Alderman Whittington."

Alderwoman Drewenski "I would like to amend that motion and include the other company until they bring their drawing back."

Mr. Abshire "LB Steel has followed all the rules in respect to acquiring the property. We came to the EDC meetings and it was approved by the EDC, We came before City Council and they tabled it back to EDC. We have offered a cash deal to purchase this property and I have the drawing tonight and I dropped them off a week ago and we are offering to buy the property. We are here tonight to do business."

Mr. Hasan "Jobs come first, I wanted to purchase the Dixie Square property myself but I when I met with and saw the plans from Mr. Abshire, his plans were better than mine, so I took a back step."

Alderman Price "We still need to see, Mr. Abshire plans. I will I make a motion that they go back to EDC."

Attorney Lewis "I think you should start over, whom ever made the motion go back and amend the first motion. And invite Ms. Ridgeways to that meeting."

Alderman Price "For the record, I would like to have the drawings he turned in.

Mayor Kellogg Resolution # 2889 send it back to EDC and let us move forward

Alderman Price motioned that Resolution #2889 go back before the Economic Development Committee and then we move forward. The motion was second by Alderman Whittington.

Voting Ayer were Aldermen Whittington, Key, and Nesbit. Voting Nay was Alderman Price. Alderwoman Drewenski - Passed

Tonight, I have in my hands a copy of the forensic audit report and in conclusion the G&P Accounting Firm – Mr. Robert Handler states "We have found no evidence that water funds were for non- Harvey purposes. The Kay Jeweler' and Kohl's Department Store they were not water related the G&P ruled these transactions non water. Let's Kiss and make up, was the name of a business that we purchased a piece of equipment from and we brought it here to City hall to show proof of purchase. Other talking points were Leadership facts, House of Cards and the Audits."

I belong here like all of you, talk about females, I am called a friction? I am a resident of the city of Harvey. This is the year of the female.. We are still talking about the last four years, too much damage has been done so when the people that got hurt were the residents. When the election is over, you have to focus on the City of Harvey. I love this city, I'm just like anyone else when the election is over let us focus on togetherness. Be careful is slippery outside. I love you even if you don't love me. Mr. Fisher, what are we going to about the street lights?"
