Alderman Randle-El the recommendation from the Legislative Committee was to remove section C under 6-08-070 under nuisances from the Ordinance.

**REMAIN IN COMMITTEE**

Ordinance #3384 - An ordinance making appropriation for corporation for the City of Harvey for the fiscal year beginning May 1,2019 and ending April 30,2019.

Alderman Randle-El Mayor can you explain the necessary of this ordinance?

Mayor Clark explained that it will be posted in the Clerk's office for 10 days for Public inspection in the Clerk's office. We have to be accountable and responsible for our spending.

Alderman Tolbert "You had this Council hire a lobbyist for \$72,000. Do you know why it is not in this budget? "

Alderwoman Drewenski "Excuse me Mayor in my time as Alderperson in nine years, we do have a surplus".

Alderman Rogers made the motion to approve Ordinance #3384 to post. The motion was second by Alderwoman Drewenski.

Voting Aye were Aldermen Key, Crudup, Alderwoman Drewenski, and Rogers.  
Voting Nay were Aldermen Randel- El and Tolbert.

Alderwoman Drewenski motioned to grant permission for the street closure for Second Baptist Church. The motion was second by Alderman Tolbert

Voting Aye were Alderwoman Drewenski, Aldermen Tolbert, Crudup, Key, Randle-El and Rodgers.


**MOTION CARRIED**
