## FACT SHEET FOR: RESIDENTIAL TAX REACTIVATION PILOT PROGRAM - SIDE LOTS

The Residential Tax Reactivation Pilot Program allows homeowners in the city of Harvey to purchase vacant city-owned lots for \$1 if the parcel meets certain program requirements.

## Eligibility Criteria for purchasing a parcel are:

• \* If Applicable Purchaser must provide proof of ownership and occupancy of the property immediately adjacent to the City parcel. Proof must be provided in the form of a recorded deed, utility bills, and photo ID.

- Purchaser must pay/escrow two years of estimated taxes on the parcel at closing.
- The parcel must be zoned Residential. The City will confirm the zoning.
- Purchaser must remain free of property maintenance or code violations.
- Purchaser cannot be a Church or tax exempt entity.
- Purchaser must not be delinquent in payment of real estate taxes and/or other debts to the City of Harvey.
- Purchase cannot sell/ rent property for five years after all code violations are redeemed.
- City Council approval will be required for all purchases.

## FEES: Are non-refundable, and payment must be in the form of a certified or cashier's check only.

- Application fee: \$50.00
- Tax escrow must be paid at closing.

## Restrictions of the parcel are below:

- 1. Buyer can only purchase one parcel.
- 2. Buyer cannot sell the parcel separate from the adjacent property.
- 3. Improvements to the parcel are limited to a residential garage, an addition to the adjacent house and/or landscaping. Any improvements to the parcel must comply with zoning, building and other City codes.
- 4. The restrictions listed above will expire 5 years after the date of conveyance.
