

APPROPRIATION ORDINANCE # 3346
AN ORDINANCE MAKING APPROPRIATIONS FOR
CORPORATE PURPOSES FOR THE CITY OF
HARVEY FOR THE FISCAL YEAR BEGINNING
MAY 1, 2016 AND ENDING APRIL 30, 2017

BE IT ORDAINED by the Mayor and City Council for the City of Harvey, Cook County, Illinois,
