LEVY ORDINANCE #3368

AN ORDINANCE LEVYING TAXES IN THE CITY OF HARVEY, COOK COUNTY, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 2018 AND ENDING APRIL 30, 2019

BE IT ORDAINDED by the Mayor and City Council of the City of Harvey, Cook County, Illinois:

ARTICLE 1

That the amount of taxes for the fiscal year commencing May 1, 2018 and ending April 30, 2019 for all corporate purposes, to be levied upon all property subject to taxation with the City of Harvey, including railroads as the same assessed and equalized for State and County purposes for said year be and the same is hereby fixed at SEVENTEEN MILLION, TWO HUNDRED SIXTY-TWO THOUSAND AND FORTY-EIGHT DOLLARS (\$17,262,048) and said sum is hereby accordingly levied upon all property in said City subject to taxation aforesaid.

That the said sum SEVENTEEN MILLION, TWO HUNDRED SIXTY-TWO THOUSAND AND FORTY-EIGHT DOLLARS (\$17,262,048) being taxes to be levied for the fiscal year of this ordinance shall, when received, be used for the purpose of paying the following items for each of which an appropriation has been made in and by an Appropriation Ordinance passed by the Council of the City of Harvey; that the specific items as they appear in the Appropriation Ordinance are itemized hereinafter in the column headed "Appropriation" and the specific items and the amounts herein and hereby are listed in the column headed "From Tax Levy."

ARTICLE III

The Mayor is empowered and directed to execute and to cause to be filed with the County Clerk of Compliance with the Truth in Taxation Act, the term requirements and conditions of which have been met at and before the adoption of this ordinance.

ARTICLE IV

The City Clerk of the City of Harvey be and is directed to forthwith file a certified copy of this ordinance with the Clerk of Cook County for the purpose of having extended the taxes levied under the terms hereof and to enable the proper authorities to collect the same when extended.

ARTICLE V

This ordinance shall be in full force and effect ten days from and after its passage and approval as required by law. Publication in pamphlet form is authorized.
