- 1. When does the project have to be completed? By 12/31/2022.
- 2. Will the Contractor be responsible for moving vehicles within the construction area? No, the City will be responsible for coordinating relocation of vehicles within the construction area.
- 3. Only the roadway travel lane will be improved?

Yes. The roadway travel lane is approximately 26' wide.

- 4. Are the parking areas adjacent to the roadway travel to be improved? No.
- 5. What is required for erosion control?

Inlet protection and ditch checks if any storm structures or ditches are encountered within the right-of-way.

6. What is full depth pavement removal?

Full Depth Pavement Removal has been removed from the scope of work and the Bid Form has been revised.

- 7. Are the MBE and WBE percentages in the Bid Package a goal or requirement? *Goal.*
- 8. Where are Thermoplastic Pavement Markings being used?

Intersection crosswalks. The Bid Form has been revised with updated Thermoplastic Pavement Marking quantities.
