**ORDINANCES AND RESOLUTIONS FOR THE CITY OF HARVEY.**

**RESOLUTION # 3006** - A Resolution Authorizing the Mayor or Designee to Negotiate and Enter into an Agreement with DACRA Tech LLC (DACRA) to Implement a Municipal Enforcement System Subject to Final Legal Review and Approval.

Deputy Chief Biddings explained that this new software would make it easier to process e-tickets, tow fees, parking compliance and much more. This will make it a lot easier for the record staff to go into the system to track the citations. This program is \$2,000.00 a month for 500 tickets a month.

Mayor said this will give us a more centralized system.

Alderman Randle-El asked if this program would pay for itself.

Deputy Chief that it would pay for itself probably in the first year.

Alderman Key wanted to know if the tickets from previous year would be uploaded also.

Deputy Chief stated that they would load some years back but he wasn't sure how far back and he would find out and let the Council know later.

Alderwoman Drewenski asked if this would also help with the abandonment of vehicles in the City.

Deputy Chief Biddings said that this software would give out red flags like seven-day notices and they would see what abandoned vehicles were still out there.

Mayor Clark mentioned that this type of program gives the City of Harvey Police Department accountability, transparency, and credibility to show where the money is going from the police department.

Treasure Pickett asked if the individuals would receive a letter in the mail if they did not pay their bills on time.

Deputy Chief Biddings said they would receive letters in the mail if the individual forgot to pay their citation or needed a court date.

Mayor Clark said that the individual would receive their notifications in a timely fashion in the way they should.

Alderman Randle-El made the motion to approve the Resolution.
