<u>Ordinance – # 3460</u> - An Ordinance Approving a Text Amendment to the Zoning Ordinance of the City of Harvey Regarding Cannabis Business Establishments.

Alderman Randle-El commented that he had concerns of the distance from this type of business being to close to a daycare.

Alderman Rogers said he had seen that it was one thousand feet from establishments such as daycare, churches, hospital, etc.

Alderman Key stated that the only problem for this Ordinance is the distance from these cannabis establishments to certain other establishments such as daycare centers, etc.

Mayor Clark said that that Council can still make adjustments to this Ordinance.

Alderwoman Drewenski asked what the distance is from a liquor store to such establishments as were being discussed.

Attorney stated that it was only 100 ft. He said that he sees that the aldermen have concerns about the distance between the establishments. He said that Council can approve but subject to conditions like the screening of the distance. He said that they would get an opportunity to look at each and every location of a cannabis business coming through with the special use process.
