ORDINANCE NO. 3494

BE IT RESOLVED by the Mayor and City Council of the City of Harvey, Cook County, Illinois, THAT:

**AN ORDINANCE ESTABLISHING
FEES, FINES, INSURANCE AND GUARANTEE REQUIREMENTS**

shall be, and is hereby, adopted as follows:

Section 1. BACKGROUND.

The City of Harvey, pursuant to authority granted in the Illinois Municipal Code, 65 ILCS 5-1-1-1 et seq., has established a comprehensive code of regulations and licensing provisions, and pursuant to its licensing and general regulatory powers, as well as Section 1-2-1.1 and Section 1-2-1, 65 ILCS 5/1-2-1.1 and 65 ILCS 5/1-2-1, the Village has established a series of fees and other monetary charges to recapture the cost of administering said regulations and licensing provisions and seeks to ensure compliance with, and conduct enforcement related to, these provisions.

The Mayor and City Council of the City of Harvey desire to establish a user-friendly list of fees, fines, insurance and guarantee requirements in the City Code that may be easily reviewed by the public, elected officials, and City staff. The Mayor and Board of Trustees may periodically amend this schedule of fees, fines, insurance and guarantee requirements through the adoption of subsequent ordinances to ensure appropriate cost recovery for City services and enforcement of penalties for violations of City ordinances.

Section 2. AMENDMENTS.

- A. Title 3, Revenue and Taxes, of the City of Harvey Code of Ordinances is hereby amended with the adoption of the new Chapter 3-01, Fees, Fines, Insurance and Guarantee Requirements, including the sections and tables as fully set forth in *Exhibit 1*, which is attached and incorporated herein by reference.
- B. All references to fees and fines in the City Code cited in Exhibit 1 shall be stricken and replaced with a reference to "Chapter 3-01, Fees, Fines, Insurance and Guarantee Requirements."
- C. **All fines and fees as shown in the Fee & Fine Schedule (Exhibit 1) should increase annually, in an amount equal to the Consumer Price Index or Cost of Living Index for the area most closely representing the City. All amounts should be rounded to the nearest dollar.**
- D. Title 1, General Provisions, of the City of Harvey Code of Ordinances is hereby amended with the addition of new Section 1-04-125, as follows (additions in **bold and underline**):

1-04-125. Collection Fees.

All unpaid fees, fines, debts, and other amounts owed to the City and transferred for collection shall include a collection fee as set forth in Chapter 3-01, Fees, Fines, Insurance and Guarantee Requirements to offset costs incurred by the City.

Section 3. APPLICABILITY.

- A. Each fee, fine, insurance or guarantee requirement set forth in this Ordinance shall apply to the provisions of the corresponding section, subsection, or paragraph of the City of Harvey's Municipal Code, as amended, or other ordinance cited in Exhibit 1. Any fee or fine inadvertently omitted from Exhibit 1 shall remain in effect until otherwise amended.
- B. It is intended that the fees, fines, insurance and guarantee requirements set forth in this Ordinance will be reviewed periodically by the City's corporate authorities, and some or all of the provisions of this Ordinance may be amended from time to time. Each provision of this Ordinance shall remain in full force and effect unless otherwise expressly provided or expressly amended by a subsequent ordinance, in which case the amended provisions shall be immediately effective.

Section 4. CONFLICT.

- A. In the event a conflict exists between the terms of this Ordinance and any other ordinance or resolution of the City, the terms of this Ordinance shall govern.
- B. If any section, paragraph, clause, phrase, provision or part of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, clause, phrase, provision or part shall not affect the validity of any of the remaining provisions of this Ordinance.

Section 5. EFFECTIVE DATE.

This Ordinance shall be in full force and effect from and after its passage, approval, and publication in the manner provided by law.


